004/2024 Public Participation

Cornwall Councillor Jane Pascoe reported that: the new recycling schedule had been introduced to St Keyne; residents with issues over collection are asked to report direct to Cornwall Council (see below) but not to repeat requests; has met with CC Highways to discuss flooding at Penhale Road and had raised the issue with the CC Portfolio Holder for Transport Cllr Richard Williams-Pears. The farmer who owns the land adjacent to the flooded road is unable to take remedial action until water levels recede but is aware of local concerns. Cllr Toms reported that: work was ongoing to remedy the landslip at West Looe; increased numbers of potholes are being reported and repaired by CC; congratulated the Chair and council on its successful challenge to planning application PA23/04569 (see Item 6C below)

Cllr Shovelton welcomed Trewidland resident Mhairi Mackie to explain how the recently adopted Dobwalls & Trewidland Neighbourhood Plan could be applied. He thanked her for her work on this project over the past seven years, and looked forward to using the plan as a tool in the council's scrutiny of planning applications.

In making their decision, councillors noted that although the application had satisfied their concerns about biodiversity, waste disposal and design, the proposal lay outside the development boundary that had been defined in the Neighbourhood Plan.

Proposal Proposed extension and alterations.

Location 2 Valley View St Keyne Liskeard Cornwall

It was **Resolved to support** this application. Proposed Cllr Hopwood. Seconded Cllr Lindsey Ellis. All agreed. Councillors noted that the extension and alterations were designed to be sympathetic to the existing structure and there were no issues with neighbouring properties.

The Chair reminded councillors that they had previously agreed a response to these notifications with concerns about the cumulative impact that clusters of dwellings not requiring consent could have.
