## 91/2022 Chair's Welcome & Housekeeping

## 92/2022 Public Participation

Cornwall Councillor Jane Pascoe reported that: the structure of Community Network Panels (CNP) are under review and may result in merging Liskeard & Looe with Gateway; consultation with parish councils is ongoing; the Shared Prosperity Fund has received 25 applications totalling £15m and the new Cornwall and IOS Economic Prosperity Board is currently assessing them; Cosmic Girl the adapted Jumbo jet touched down at the Cornwall Spaceport last night, marking the beginning of the Space Programme in Cornwall; Community Chest grant application for £360.28 for the flag pole and flags in the village of St Keyne approved; a planning enforcement notice for has been issued on the site known as Land North of Rosenun (.PA22/02426). The landowners have 6 months to comply, cease use, remove all machinery and return the site to its original state.

Cllr Armand Toms reported that: attended the Health and Adult Social Care Overview and Scrutiny Committee which discussed ways to balance its budget when faced with increased costs of wages and energy; a new scanner has been delivered to Bodmin Hospital that will improve access for patients who would usually travel to Treliske or Derriford; is campaigning to create a banking hub in Looe that would provide facilities for residents after January 2023 when the last bank in the town closes.

Representatives from Morval Parish Council attended to give their support for a joined-up approach to improving road safety on the B3252. This matter will be discussed at the next CNP meeting in January 2023, and proposals may be submitted as Expressions of Interest in the forthcoming highways plan.

**Action**: Clerk to organise Zoom meeting with St Keyne & Trewidland, Morval and Menheniot Parish Councils, and Cornwall Council Highways.
