105/2022 Chair's Welcome & Housekeeping

The Chair welcomed everyone to the meeting and thanked the 12 people who had attended the recent defibrillator training at Trewidland village hall. Training will be running again in St Keyne in April 2023.

106/2022 Public Participation

Cornwall Councillor Armand Toms reported that: Cabinet had met yesterday to propose that for 2023/24, council tax would increase by 2.99% (inclusive of a 1% Adult Social Care precept), and that the Foundation Living Wage increases (to £10.90 per hour) for Council staff and where FLW is paid as part of their contractual arrangements with suppliers and providers. Reports continuing issues with health services across the county which may exacerbate as we approach the winter season.

Cornwall Councillor Jane Pascoe reported that: consultation on the restructuring of Community Network Areas will take place via Teams meeting on Monday 14 November at 6pm. Current proposal is for the Liskeard-Looe area to merge with Cornwall Gateway, increasing the number of parishes in that group from 18 to 29. Her concerns are that there will be an appropriate increase in funding and resources to meet the scope of work.

Mhairi Mackie attended to present an update on the Dobwalls & Trewidland Neighbourhood Development Plan. The organising group has now submitted its proposals to Cornwall Council under Regulation 15 to allow it to carry out Legal Compliance and Comprehensive Impact checks. All documents available online.
