# Safeguarding

### 1.0 Background

1.1 In October 2022, Cornwall Council and CALC jointly launched a toolkit to provide information to parish councils about safeguarding. Safeguarding is about protecting children, young people and adults who are vulnerable from abuse or neglect. This Briefing Note explains what the toolkit includes, and how parish councils can improve their understanding of safeguarding. The eventual aim is for the council to agree a safeguarding policy, be able to make an informed response to concerns about safeguarding and be a model of good practice that other stakeholders in the parish are encouraged to copy.

#### 2.0 The toolkit

2.1 The document has been produced by Cornwall Council as a guide to parishes who wish to understand what safeguarding is and why having policies and practices is important. It explains in detail what the different kinds of abuse are (distinguishing between adults and children & young people), how to create a safeguarding policy and how to report concerns. #### 3.0 The current situation

3.1 CALC is asking that councils undertake a review of your safeguarding arrangements or put them into place for the first time. At the time of writing, this council makes one single reference to safeguarding in the terms and conditions attached to its donations application form. Currently, there are no actions in place to follow up the condition, to promote awareness of safeguarding among beneficiaries of your donations or other stakeholders in the parish.

#### 4.0 The proposal

4.1 The Chair is asking that at their next meeting, councillors discuss and agree to recognise the importance of safeguarding and further agree to set up a working group to manage its response to CALC's concerns. This would mean asking for volunteers to create a policy and guidelines for implementation. The scope of work would be to:

- Review the Safeguarding Toolkit for Town & Parish Councils
- Advise councillors on the importance of making safeguarding a priority
- Support the adoption of a 'designated person' for safeguarding
- Create a policy statement
- Identify training needs and manage their delivery

Outputs

- Draft safeguarding policy for councillors to adopt
- Action plan for adoption
- Role profile for designated lead (if agreed)
