Cllr Toms reported that: Looe Police Station was now open 6 days per week from 10am to 3pm; funding for road improvements to the A38 starting in 2025 is becoming available; is campaigning for ANPR to be used to pay for tolls across the Tamar Bridge in order to speed up traffic flow.

A Cllr Blackwell reported that he attended a recent St Keyne Village Hall committee meeting, and that: the Committee is happy to accept the donation of a portrait of HM King Charles III for public display; the project to purchase and install solar panels was proceeding; have considered the installation of an EV charging point but the building lacks the essential power supply needed to charge.

Cllr Woodman attended a recent Trewidland Village Hall Committee and reported that: use of the hall for indoor events was increasing; some minor issues regarding unauthorised parking at the hall were being resolved; a Spring Art Exhibition will take place on 23-24 March 2024 fundraising for the Cornwall Air Ambulance; will accept a donation of a portrait of HM King Charles III.

The first Trewidland litter pick took place on 24 February 2024 when 19 people attended and collected 7 full bags of litter and waste. The second pick will take place on Saturday 20 April. The Chair thanked Cllr Woodman (and family) for organising and managing the litter pick.
